JUVENILE DRUG COURT TREATMENT PROGRAM

The Juvenile Drug Court Treatment program provides Outpatient services to adolescents experiencing life problems that may be related to their use of alcohol or illicit substances.

The target population is adolescents with drug use disorders of abuse or dependence and are in the Pre and/or Post Adjudication Process within the legal system. The program utilizes the A.C.R.A. manual and parenting sessions. This research-based approach has been proven to be effective with youth.

This intervention focuses on teaching adolescents how to find new reinforcers or enhance existing reinforcers for staying substance free, how to use existing community resources that were believed to support positive change, and how to develop a positive support system within the family. The program also recognizes the powerful influence parents have on youth's behavior and focuses on helping the parents develop the skills to parent their children in

more effective ways and supporting their recovery efforts.

SERVICES PROVIDED:

- AN INDIVIDUAL COMPREHENSIVE ASSESSMENT /EVALUATION
- TEN INDIVIDUAL SESSIONS W/ADOLESCENT, TWO INDIVIDUAL SESSIONS W/CAREGIVER; AND/OR TWO SESSIONS WITH ADOLESCENT AND CAREGIVER TOGETHER
- INDIVIDUALIZED TREATMENT AND DISCHARGE PLANNING
- REVIEW HEARING, AS NEEDED
- WRAPAROUND MEETINGS
- DRUG TESTING AS NEEDED THROUGHOUT PROGRAM
- PARENT-EDUCATION SESSIONS
- HOME VISITS
- CASE MANAGEMENT
- REFERRAL AND FOLLOW-UP

PROGRAM OVERVIEW

1. Individual is referred for services by court official, probation officer or any other court and/or legal representative.
2. A substance abuse screening and assessment is initiated.
3. If individual qualifies for program and is willing to participate in services, a comprehensive intake is done with individual.
4. Each individual who is admitted to the program will be involved in a curriculum-based treatment which consists of ten individual sessions and two sessions with caregiver.
5. Parent Education sessions are provided during program participation.
6. Review hearings will be held on a weekly, bi-weekly; and/or on a monthly basis.
7. Wraparound meetings are held at least once during their treatment process.
